#### An overview of the training course:

Two batches of Taxation Inspectors have been made who were selected by the Haryana Staff Selection Commission for Foundation Training Programme at HIPA Gurugram. In the first batch 67 participants were called for joining the online training classes conducted by the training centre of Excise and Taxation Department at HIPA from dated September 6<sup>th</sup> to December 6<sup>th</sup>, 2021 due to the pandemic covid-19. Keeping in view the circumstances and situation of covid-19, it was further decided to conduct offline classroom training of the participants from November  $08^{th}$  to  $27^{th}$ , 2021 so that practical aspect of the training and interaction could be made.

## **Art of Living :**

As a part of the training schedule a special course was organized by the HIPA through the Art of Living Organisation Bangalore. This course has been implemented by the government for their executives. In this course breathing technique was learnt by the participants through the process of Sudarshan Kiriya in four days. This course is also known as happiness program was conducted by Swami Shiv Pad Ji, an international faculty of the organisation. The aim of the course was to enhance the capability, self-motivation, making life a pleasure and connecting with the self of the trainees. All the participants enjoyed and felt energized by the programme and appreciated highly.



#### **Course Delivery Mode:**

Focus of imparting training was not confined only to lecture mode of teaching, but to make sessions more interactive and absorbing videos, group discussions, role play and other modes of teaching were employed. Study material was distributed on important topics to explain the issues in some detail and encourage further reading on the subject.

Several approaches and procedures were used to deliver the training instructions to support and embed learning process in this foundation course. These comprised mainly:

- Lectures by both in-house and guest faculty
- Case studies
- Use of audio visual aids showing film etc.
- Group discussions
- Practical Demonstrations
- Written paper for evaluation

## Study Tour Programme – Bhopal, Madhya Pradesh

The participants reached at Rani Kamlapati railway station of Bhopal which is inaugurated by the Prime Minister recently and is one of the unique station in the country which look like the airport modal. The Bhopal city is also known as the city of lakes because is surrounded by the lakes on the outskirt of the boundary. The boat club is very famous for the boating of the visitors in the city and the trainees participants enjoyed the boating in the lake which was very amazing.





#### Batik Printing – Bherugarh, Ujjain:

In Ujjain the participants were welcome by the team of GST officers of the state of MP led by Smt. Vinita Jaise Sharma, Deputy Commissioner and appraised about the topography and culture of the Ujjain city. She has also organised the holy visit of the Mahakaleshwar Jyotirlinga for the religious enrichment of the trainees participants beside the interaction regarding the functioning of the GST officers in the district.

Batik printing is one of among the various kinds of prints, and is much known in the Ujjain city. Batik is combination of art as there is a free moment of the hand while working on the patterns which are artistically done and crafted. The participants interacted with the master of batik art Abdul Raheem Gutti who has been awarded many time by the government for his contribution to the art.



## Visit of Shri Mahakaleshwar Jyotirlinga Temple, Ujjain:

A visit was organised by the academy of Bhopal for Mahakaleshwar Jyotirlinga in Ujjain, a Hindu temple dedicated to Shiva and is one of the twelve celebrated jyotirlingas in India. The temple is situated on the side of holy river Shipra. Ujjain used to be the central point for calculation of Indian time and Mahakala was considered as the distinctive presiding deity of Ujjain. One of the twelve Jyotirlingas in India, the Lingam and Mahakala is believed to be Swayambhu, driving currents of power from within itself.



## Most Clean City, Indore:

Indore city of Madhya Pradesh has been awarded the first position in India for cleanliness. It was amazing to see that there was complete cleanliness in whole of the city and not even a paper piece was found anywhere on the road or else. The NEPRA-Indore Project has been started by the corporation where wet and dry waste collected door to door and recycled. It is India's first automatic plant where the participant interacted with the management and workers. The landfill has been made by the waste of the city which has been converted into beautiful park for the convenience of the public. It was all a beyond imagination to see practically the manufacturing of Bio-Fertilizer and the Bio-Gas from the waste of the city which leads to cleanliness and earning to the government. It is role model for the country regarding the zero waste management.







## Van Vihar National Park and Zoo, Bhopal:

For the enhancement of knowledge regarding flora and fauna a visit was organised by RCVP Noronha Academy of Administration, Bhopal at Van Vihar National Park and Zoo. The participants have virtually seen the lion, tiger, snakes, tortoise, crocodile, anaconda and other animals as well as birds present in the zoo. The zoo is situated on the outskirt of the city area of 445 hectare. The Van Vihar has many all type of plantation such as Plas, Bel, Imli, Babul, Amaltas, Dudhi, Lendia, Khajoor, etc.





Interaction with the state GST Officers:

the trainees interacted with the state GST Officers in the Head office, Indore Madhya Pradesh where Sh. Anurag Jain, D.C., Sh. Ashish Saxena, D.C., Sh. S.N. Tiwari, A.C. along with their other officers organised a workshop for the enhancement of the knowledge of the trainees. It was felt by the officers of the state that such interaction among the participants should be there at interstate level which would definitely leads to increase the exchequer of the country. In that way one tax and one nation formula would be fulfilled.



For the purpose of enhancing their practical knowledge the participants visited the RCVP Noronha Academy of Administration in Bhopal. In the academy the state officers of the GST department interacted with the participants and enhanced their knowledge regarding the implementation of the GST in the state of MP. It was an academic and practical experience regarding the functioning of the department of Taxation in the two states. In overall a bridge has been created between the officers of the two states which will result into unearthing of fraudulent tax evaders. The MP Officers of the GST department promised to full cooperation in regard the detection of tax evaders if approached by the state of Haryana and vice versa.
