Seminar on Future of ICT in Governance

A half-day seminar on The Future of ICT in Governance was organized at HIPA in collaboration with Haryana Regional Branch of Indian Institute of Public Administration on April 10, 2019. Dr. Ram Sevak Sharma, IAS (Retd.) Chairman of Telecommunications Regulatory Authority of India (TRAI) was the chief guest and keynote speaker. The event was presided over by the Chairman of Haryana Regional Branch of IIPA Shri M.C. Gupta IAS (Retd.), former Secretary to Government of India and former Chief Secretary, Haryana. Dr. G. Prasanna Kumar, IAS (Retd.) Director General HIPA delivered the welcome address. Dr. Charru Malhotra Associate Professor, IIPA also presented a paper on seminar's theme. It was attended by the training participants and faculty of HIPA and the members of the Regional Branch in a large number.



In his welcome address, Dr. G. Prasanna Kumar, Director General HIPA spoke about the application of technology in the vital areas of governance and public administration which have enhanced the scope of citizen focused services. He said that the futuristic scope of information and communication technology lie in a greater interoperability of mind and computers. More evocative and accurate decision making supported by Artificial Intelligence hold promise for a holistic social and economic progress, he added.

In his lively keynote address, the chief guest Dr. R.S. Sharma recounted his experiences with the evolving technology as the Secretary, Department of Electronics and Information Technology (under Ministry of Communications and Information Technology, Government of India) and as Director General, Unique Identification Authority of India,

the custodian of Aadhar. Privy to the adoption of advanced technology, he said, he has witnessed the great potential of technology being put to use on a pan-India scale. In his presentation he showed how the journey of last one decade has integrated Aadhar based identification and authentication with the direct benefit transfers, riding upon the Jandhan initiative as a mass movement towards universal banking. He said that with a vast majority of citizens now using a mobile phone, the dream of proliferating culture of digital payments is

coming true sooner than expected. His presentation unfolded how the country has leapfrogged on the opportunity offered by ICT through a well-designed strategy. Transactions through Unified Payments Interface (UPI), the country's flagship payments platform, crossing the value of Rs 1 trillion in December 2018 is no mean achievement. Dr. Sharma said that ICT-led initiatives are designed to offer scalability, speed, inclusiveness and a cost-effective delivery mechanism.

A thematic presentation was made by Dr. Charru Malhotra, Associate Professor, Indian Institute of Public Administration, New Delhi on the emerging technologies that may address the future governance needs. She spoke about the rise of new digital industrial technology, known as Industry 4.0, a transformation that makes it possible to gather and analyze data across machines, enabling faster,

more flexible, and more efficient processes to produce higher-quality goods at reduced costs.

In his presidential address Shri M.C. Gupta, Chairman of Haryana Regional Branch of IIPA stressed that the ultimate objective of any futuristic deployment of technology should be to ensure 'Happiness' in the society. He said that the ICT has revolutionized our way of understanding the issues emerging around us and a proper approach towards finding solutions. It is heartening to see the technology settling down to a user-friendly interface making life easier even for those who are not tech-savvy, he added. Shri Gupta hoped that appropriate steps are being mooted to meet concerns like unemployment and redundancy.

DISASTER MANAGEMENT

Medical Response & Psycho-social Care in Disaster Situation



The five-day captioned training programme was organised from April 8-12, 2019. The objectives of programme were to deliberate upon the role of the health sector in the overall disaster risk management; to provide guidelines to the medical practitioners to spearhead the developments of health contingency plan; to understand the key steps in managing a mass casualty incident; to explain the strategy for managing outbreak of diseases in emergency settings; and to understand the psycho-social care issues in disaster situation.

To meet the above mentioned objectives, the following major areas were covered: Impact of Disasters on Physical and Mental health, Preparedness and Mitigation for Emergency Medical Response, Preparation of Hospital Disaster Management Plan, Understanding Psychosocial Needs of Disaster Survivors, Techniques of Psychosocial Care, Mass Casualty Management, Handling Medico Legal Issues, and Incident Response System. The topics were comprehensively covered by both in-house faculty and guest faculty, including Dr. N.K. Chaudhary, Joint Commissioner, St. Johns Ambulance Services; Prof. S.K. Sharma from Army College of Medical Sciences, Delhi; Dr. Sushma Sagar, Professor of Trauma Surgery, JPN Apex Trauma Centre, AIIMS; Dr. Brahmdeep Sindhu from Department of Psychiatry, Civil Hospital, Gurugram.

Livestock Management

With an objective to enhance the capacity of veterinarians in their undertaking of mitigation, preparedness and response in disaster like situation affecting livestock and to develop skills on search and rescue of animals, a three-day Livestock Management training programme was organized from April 22-24, 2019. Sponsored by the Department of Animal Husbandry and Dairying it was conducted by Dr. Abhay Shrivastava

(ii) Another three-day training programme on Livestock Management was conducted from May 8-10, 2019 by Dr. Anshu Tiwari. The major objectives of the programme were to sensitize the veterinary doctors on disaster related livestock management; to enhance the capacity of the veterinarians in terms of mitigation, preparedness and response measures; and to develop skills on search and rescue of animals.

The three-day programme sensitized the participants through focused sessions on disaster vulnerability of animals and its mitigtion. The major topics covered are institutional mechanism for disaster mitigation and preparedness; effective disaster response to protect animals by Overview of Live Stock Sector in India and its impact to Disaster and VERU Programmes on Animals in Emergencies; Need of various Equipment for Veterinary Response at district to local level by Shri Hansen T. Prem; Safety Measures including emergency veterinary triage in Veterinary Response, Emergency Shelter and Veterinary Care; Bio-Security and Disease Control by Shri Akash Maheshwari and Assessment of affected Animals and Distribution of Relief by Shri Punita Punia, Deputy Director, Department. Of Animal Husbandry and Dairying. A case study of Live Stock Management in Gujarat Floods was also shared with the participants.

INFORMATION & COMMUNICATION TECHNOLOGY

- (I) A five-day training programme entitled Capacity Building in Information and Communication Technology (ICT) for Professional Efficiency was conducted by Dr. Devender Singh from April 15-19, 2019 at HIPA.

QUALITY MANAGEMENT

Dr. Aarti Dudeja conducted a three-day training programme on Continuous Quality Improvement on June 19-21, 2019 at DTC Panchkula. The objective of the course was to explain the concept of 'Quality' and describe its importance in enhancing productivity; to explain quality indicators relating to their functional areas; to elucidate the role that employees are expected to perform and how it is linked with organizational goals; to demonstrate the ability to use principles of office management/house-keeping; and to

identify the problems associated with the existing system and simplify the processes set up standards for better service delivery.

The main topics covered in this training were Organisational Goals, Total Quality Management in Government, Ethics And Values in Administration, Office Procedures for Improving Efficiency and Paper Management, Time Management, Leadership Quality and Team Building, etc. Shri V.P. Batra and Shri Sanjeev Chadha were invited as expert guest faculty for the programme. Twenty eight participants from various departments of Government of Haryana attended the programme.

FINANCIAL MANAGEMENT

A total of eleven training programmes and workshops were conducted for the benefit and capacity enhancement of General Managers, Financial and Administrative Officers, Finance Managers, Head of Offices, Drawing and Disbursing Officers (DDOs), and Accounts Officers working in Government Offices in various specialized areas. Dr. Lalit Kumar, Assistant Professor of Financial Management directed these programmes with other in-house faculty and domain experts from outside.

Inventory Management including Purchase through e-Procurement and Government e-Marketplace (GeM)

Conducted from April 01-03, 2019 at HIPA Rohtak and April 9-11, 2019 at HIPA, Hisar; the main objective of the three-day courses was to build and enhance the capacities of officers to manage the inventory, i.e. store items with proper compliance of purchase rules in procurement using e-Procurement and Government e-Marketplace (GeM). At the conclusion of this course participants will be familiar with the (i) process of management of inventory, from preparing store requirements to purchase, and management of goods and assets; (ii) modalities of purchase procedures as described in Punjab Financial Rules including local purchases and manual tendering; (iii) and with use the portal of e-Procurement in Haryana for e-Tendering and Government e-Marketplace (GeM)



Workshop on Human Resource Management System

Organized on 18th April, 2019 at HIPA, Hisar, the main objective of the course was to build and enhance the capacities of officers to use Human Resource Management



System (HRMS) using portal of Haryana Government's Treasuries Department. The one-day workshop organized at Hisar on April 18, 2019 was attended by twenty officers from the targeted group. The participants learnt about the module of Human Resource Management System (HRMS) implemented by Haryana Government and use the portal for maintenance of Service Book and issuing orders through HRMS as per the directions of Haryana Government.

Income Tax Matters for Drawing and Disbursing Officers

The two three-day courses, organized from May 08-10, 2019 at Hisar and May 22-24, 2019 at Rohtak, were designed to sharpen the skills of officers particularly in relation with income tax and tax deduction at source (TDS) ensuring compliance of Income Tax Act in their offices. The participants were imparted proficiency in the provisions of Income Tax with latest amendments for the Financial Year 2019-20 regarding TDS, particularly e-TDS return (24Q).

Workshop on e-TDS (Tax Deduction at Source)

The one-day workshop organized at Hisar on May 17, 2019 meant for officers handling taxation matters in the respective departments was designed to sharpen the taxation skills of trainee officers particularly regarding compliance with the income tax and GST taxation rules. The participants learnt nitty-gritty of computation and deduction of TDS from the salary and other payments to employees and vendors besides Sec. 24Q compliant e-TDS return.

Workshop on e-Filing of Income Tax Return (ITR)

Conducted from May 30-31, 2019 at HIPA Rohtak, the course aimed at sharpening the taxation skills of officials particularly in computing the tax and e-filing of Income Tax Return (ITR). Through this training intervention the participants gained proficiency in computing and preparing income details according to e-filing guidelines and submit return on Income Tax portal.

Workshop on Tally-based Inventory Management

Organized at Hisar on June 3, 2019, the course is designed to sharpen the skills of government officers particularly for managing inventories with the use of software – Tally.

Meant for the officers and other functionaries dealing with inventory management, the programme imparted necessary skills to use multiple features of Tally software for inventory accounting and generate various reports.

E-Finance Applications including e-Billing, e-TDS, and HRMS

Conducted from June 10-12, 2019 at HIPA Rohtak and June 17-19, 2019 at HIPA, Hisar, the objective of this programme was to enhance the capacity of officers to perform the e-Finance applications including e-Billing, e-TDS, and Human Resource Management System (HRMS). The target group also included Executive Engineers, SDOs, and other officers concerned with functions of e-Billing, e-TDS, and HRMS. By attending this programme the participants could appreciate the related modules of Integrated Financial Management Information System including e-bill verification and e-TDS remittance through the portal of Haryana e-Treasuries. They got proficiency in the use of online Human Resource Management System for Administrative Functions.

Workshop on Online Budgeting for Drawing and Disbursing Officers (DDOs)

Organized on 24th June at Hisar, the workshop aimed at enhancing skills for estimation of budgeted expenditures, appropriate booking of expenditures, and use of online budgeting techniques for enforcing budgetary control. By the end of this course participants are expected to gain a working proficiency in the newly introduced process of online budgeting and budgetary control in government including appropriate and budget head specific classification of expenditures.

ENVIRONMENT

The five-day training programme on Environmental Pollution and its Health Impact was conducted by Dr. Bhuwan Kumar from May 13-17, 2019. The course was sponsored by Department of Environment and Climate Change, Government of Haryana. Participants were drawn from various government departments.
